## Dear Friends,

You have likely heard by now that the Nafzigers are returning to Germany. Cadence has given us the opportunity to once again direct the **Kaiserslautern Hospitality House** where we ministered from 1993 to 2000. We will be filling in for three months, possibly longer depending on the arrival of our replacements. Our flight is scheduled for June 12, although travel these days is a bit uncertain. We are eager to get there and begin reaching out to military members!

For the last three months, we have waited on the Lord, prayed, discussed, and wondered if this would actually happen. We are currently on Home Assignment in Las Vegas and have not started the ministry at Nellis and Creech Air Force Bases, so we can't think of any reason not to go.

For nearly 50 years, the Kaiserslautern (K-town) Hospitality House has been located in the village of Hohenecken, a short distance from Ramstein Air Base, Landstuhl Army Hospital, and multiple other American military installations. The Kaiserslautern Military Community (KMC) is still the largest U.S. military community outside of the United States. Although there are a few Englishspeaking churches in the area, the opportunity for gospel ministry with Airmen and Soldiers is huge, especially if the current COVID-19 restrictions are reduced or ended. We have read recent articles that indicate that as summer approaches, things will begin to loosen up.

The K-town Hospitality House ministry went on hold when the previous directors needed to leave in March. This means we have the enormous privilege of starting it up again. We will be contacting the chaplains and already know of friends who are stationed there and willing to help. We believe these next few months will be a very strategic and exciting time for ministry.

Sue and I are aware of many of you who pray for us, and we are very grateful. The Lord has answered those prayers! For 30 years He has blessed us with exactly what we need from month to month. Amazing grace! A few of the health concerns we had earlier in the year have resolved themselves for the most part. Sue still has occasional facial burning sensations and numbness from the trigeminal neuralgia, but the dental work we were so concerned about is now complete and she is doing much better. It's as if the Lord has prepared us for this new assignment.

The Apostle Paul told the church at Corinth of his desire to visit them but decided for the time being that *"he would remain in Ephesus. . . for a wide door for effective service has opened to me and there are many adversaries"* (1 Cor. 15:9).



He was optimistic but expected opposition. **Please pray** for us as we go, that the door for the gospel would open wide and whatever opposition we might encounter would not deter us from sharing the gospel and our lives with those we meet. Pray also for our family who we will miss greatly!

Our hearts overflow with thanksgiving each and every month as many of you give and pray faithfully for us. Thank you! Our monthly expenses will soon increase as we take on the operating expenses for the ministry in Germany. We are praying for a house full of Airmen and Soldiers which means a lot of food (!) along with other expenses. Thank you for joining us in this new ministry. Your friendship continues to be a source of strength and encouragement and we thank the Lord for you! "We should follow our Lord as unhesitatingly as sheep follow their shepherd, for He has a right to lead us wherever He pleases. We are not our own, we are bought with a price—let us recognize the rights of the redeeming blood.
