Ministry at a hospitality house usually includes Bible studies, worship, shared meals, outreach, discipleship, mission trips, excursions, and various activities designed to grow a healthy Christ-centered community.

I will have the privilege to serve with a family with whom I did a past internship. Ben and Melody Bloker have been with Cadence serving in Killeen, Texas for the past eight years and are moving to Rota, Spain to run the ministry at a hospitality house there. They will be serving the Naval Station Rota military community. They have graciously invited me to be part of their ministry by homeschooling and nannying two of their daughters. I will be living in The Villa Hospitality House with the Blokers, learning from them how they do ministry while also serving with the skills I have gained at Moody. I am so excited to get to serve them in this way!
