This upcoming summer, I have the exciting opportunity to serve as an Intern with Cadence International. Cadence is an evangelical mission agency dedicated to reaching U.S. and foreign military personnel and their families with the good news of Jesus Christ. Founded in 1954, Cadence’s mission is “to share the gospel and our lives with the military community.”

With a focus on U.S. military communities, I will partner with local Cadence staff who serve near Fort Benning, Georgia. Fort Benning, known as the “home of the infantry,” is home to more than 26,000 service members and their families. During my internship, I will experience military ministry, be discipled in my walk with Jesus, and receive training to be better equipped for Kingdom work.

I will be doing Cadence Children’s Ministry (CCM), partnering with the base chapel to host weekly and monthly events that offer a safe, fun environment for military children. Each program allows them to hear the gospel through Bible lessons, songs, Scripture memory, and games. CCM outreach also extends to military families and communities. As I serve, I will be equipped to teach the Bible, lead small groups, plan an outreach event, and develop fruitful relationships with children and families.

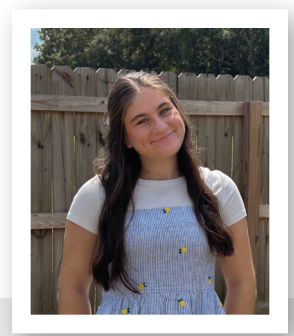
I have chosen to serve with Cadence because I’ve personally experienced the love and support they offer military families. While my family was stationed in Okinawa, I was involved in the Cadence Middle School ministry, and it was during my first summer camp there that I came to faith. The leaders continued to invest in me long after that camp

and became like family to me. Leaving Okinawa was difficult because of the deep relationships I had built, but years later, after graduating high school, I reconnected with Katie, my former youth leader, who invited me to serve as a summer Intern. I’m grateful for the chance not only to return to a ministry that shaped me but also to pour into others the way I was poured into.

My internship cannot be done alone. I need prayer and financial partners. Would you consider joining me? I need to raise \$8,029 by May 1 to take part in this unique ministry opportunity. This amount includes all my travel and ministry expenses, as well as a small salary. It also covers all the expenses to allow me to participate in Cadence’s worldwide conference in June.
